

## FY 2023 - 2025 VAWA Implementation Planning Timeline and Expectations

---

The Oregon Department of Justice, Crime Victim and Survivor Services Division (CVSSD) includes representatives from Law Enforcement, Prosecution, Courts, Tribal Nations, underserved communities, population specific organizations and others as it begins an ongoing 3 – 4-year planning process for the FY 2022 - 2025 VAWA Implementation Plan for Oregon. The current plan [FY 2022 – 2025 VAWA Implementation Plan for Oregon](#) and its [appendices](#) was approved by OVW in September 2022. CVSSD will post required plan updates to statistics with each annual federal application submission.

The following list includes identified members of the IP Subcommittee and others involved in the ongoing planning process. The identified IP tasks and discussion points are listed below to ensure that everyone across the state has advance notice. CVSSD addresses any updates to statistics included in the IP in the first two years and will propose revisions as the statewide funding priorities, goals and objectives are addressed. A statewide survey identifying gaps and needs will be released in FY 2025. The new IP will be developed with new statistics in Fall FY 2025. A draft version of the new IP will be released across the state for a public commenting period prior to final submission to the Office on Violence Against Women (OVW) in Spring FY 2026.

The following activities occurred in 2022:

- CVSSD along with members of the VAWA Implementation Planning Subcommittee completed the Draft FY 2022 – 2025 VAWA Implementation Plan for Oregon. It was released for a 30-day public commenting period.
- CVSSD submitted the FY 2022 – 2025 VAWA Implementation Plan for Oregon to the Office on Violence Against Women (OVW) in June 2022. OVW approved the plan in September 2022 and it's posted on the VAWA webpage along with the appendices.
- A 3-year FY 2023 – 2025 VAWA Competitive RFA for Law Enforcement, Prosecution, and Courts was released on July 28, 2022. The solicitation closed on September 12, 2022. Competitive review teams scored the applications and made recommendations that were presented to the CVSSD Advisory Committee and the Attorney General for approval. Three law enforcement, four prosecution, one noncompetitive court and two statewide training projects were awarded more than \$3.6 million VAWA grant funds for January 1, 2023 – December 31, 2025.
- CVSSD held a statewide Tribal Nations meeting on October 26, 2022. The 2-hour web ex meeting initiates the Community Collaboration Tour in 2023 and the ongoing work.
- CVSSD will hold a statewide VAWA Implementation Planning Subcommittee meeting on December 13, 2022. The group will address next steps for statewide goals and activities for the next 3 years. The following activities will occur over the next three years.

<p>CVSSD initiates the Community Collaboration and Needs Assessment Project with a focus on victim service needs and gaps, collaboration, successes and challenges or barriers to service delivery. A VAWA IP Subcommittee member and the VAWA Lead will hold stakeholder/community partner meetings in various locations around the state between February – September 2023. ## FY 2023 - 2025 VAWA Implementation Planning Timeline and Expectations

A final plan, approved by the CVSSD Advisory Committee and vetted across the state through a 30 - 60-day public commenting period, will be submitted to OVW along with the 2026 federal application. The anticipated date of submission is May 2026. All required VAWA IP Subcommittee members that represent statutorily required allocation categories will submit a “Documentation of Collaboration” form that outlines their involvement with the IP planning process along with any recommendations.
